COMPASSIONATE PRICING PROGRAM

Our Compassionate Pricing Program offers eligible customers a 20% discount on our full range of medical cannabis products. Eligibility requirements are shown in the table below.

Eligibility	Required Supporting Documents
Annual income of \$35,000 or less	<ul style="list-style-type: none"> Notice of Assessment (NOA) that indicates your name, address, and line 15000 (gross income) OR T5007 Statement of Benefits Form
Enrolment in a federal or provincial financial assistance program	Proof of enrolment in CPP Disability (T4A(P) Line 16), ODSP, AISH, SAID, or other provincial program
Enrolment in Employment Insurance (EI)	<ul style="list-style-type: none"> Most recent bank statement, showing your name and proof of deposit (cannot be joint account) OR EI statement/approval letter dated within last three months
Employment as first responder in the role of paramedic, firefighter, police officer, 911 dispatcher or correctional officer	Proof of employment or identification showing that you are currently employed as a first responder
Status as a retired or active member of the Canadian military not approved for coverage by Medavie Blue Cross (see “Veterans” below for those that may qualify for coverage)	Proof of retirement or identification showing you were or are currently serving in the military
Being under the age of 18 and having a medical condition for which cannabis is authorized by a healthcare provider	Submission of a medical document by a prescribing Healthcare professional.

HOW TO APPLY FOR COMPASSIONATE PRICING

When completing your registration, or any time after your registration is completed, you can submit your supporting documentation via email, mail or fax.

If you submit by email, please ensure that the subject line message includes your name and the message "Compassionate Care supporting documents."

Please ensure that all supporting documents you submit are redacted, leaving only the required line items visible. For example, when submitting your NOA, ensure your document reveals only your name, address, and line 15000.

At any time during your registration with Spectrum Therapeutics, if your personal situation changes in such a way that you become eligible for compassionate pricing, you may submit your request for compassionate pricing and your supporting documents.

WHAT ELSE CAN MAKE MEDICAL CANNABIS MORE AFFORDABLE?

- **It is a medical expense:** You may claim your medical cannabis expense on your income tax return, under Line 330 – *Medical expenses for self, spouse or common-law partner, and your dependent children born in 1997 or later*. To obtain your receipts, just log in to your Spectrum account, click on "My Account," and scroll down to your order history.
- **It may be covered by your insurance or Health Spending Account (HSA):** If you have medical insurance, we encourage you to inquire if medical cannabis is covered either as a drug benefit or by expensing through your Health Spending Account.
